Enhancement Work Completed 2017

- Cleared 5 streams from estuaries to springs (60km)
- Constructed 25 brush mats to collect silt
- Planted 1000 native trees and shrubs with rabbit protection
- Tested stream and surface water weekly at 10 locations
- ◊ Canada Day Educational Booth
- Measured shoreline erosion at 10 worst spots
- Cleaned Covehead & Brackley
 Bay shorelines
- Displayed activities on website and Facebook
- Monthly fish sampling at 6 sites in Covehead and Brackley Bays (CAMP Program)
- Cooperated with Farmers on Nutrient Management Planning

- Measured oxygen and temperatures hourly in Black River estuary
- Monitored bays and estuaries for anoxic events
- Constructed 9 rock dams in field drainage ditch
- Collected sea lettuce for composting
- Purchased new Nitrate Testing Photometer
- Replaced alders with native trees and food shrubs
- Completed annual spring runoff and redd surveys
- Negotiated with the Province and Winter River Tracadie Bay Watershed Group to acquire new territory in the Dalvay watershed

The Province Needs Your Help Tracking Bat Populations

Bat populations across Eastern North America have experienced drastic declines in the past decade due to the onset of white-nose syndrome. This disease afflicts bats during hibernation, causing them to emerge during the winter months when adequate food resources are unavailable. Until recently, it was thought that the majority of PEI's summer bat population over-wintered in caves and mines in Nova Scotia and New Brunswick. However, we now know that abandoned hand-dug wells on PEI are used as hibernacula by relatively small groups of bats. To date we have identified 2 such features, but there may be many more active and important sites that we are currently unaware of. Knowing where these overwintering sites occur is extremely important for the long term conservation of bats on PEI.

Lorne Kielly passed away on Friday 2 June 2017. He was a founding member of the Friends of Covehead Brackley Bays and was our longest serving Director ever from 2001 to 2014.

Lorne's intimate knowledge of local fish, bird and wildlife made him the "go-to" guy for advice on restoration projects involving silt, ponds, wetlands, fish spawning sites, spring releases, etc. He was also a living version of the 1880 Atlas since he knew every property owner and their history. His invariably sunny disposition made it a joy to be with him. Our community will miss him, his legacy is all around us.
