Enhancement Work Completed 2018

- Cleared 5 streams from estuaries to springs (60km)
- ♦ Constructed 25 brush mats to collect silt
- Planted 1000 native trees and shrubs with rabbit protection
- ♦ Tested stream and surface water weekly at 10 locations
- ♦ Canada Day Educational Booth
- Measured shoreline erosion at 10 worst spots
- Cleaned Covehead & Brackley
 Bay shorelines
- Displayed activities on website and Facebook
- Monthly fish sampling at 6
 sites in Covehead and Brackley
 Bays (CAMP Program)
- Cooperated with Farmers on Nutrient Management Planning

- Measured oxygen and temperatures hourly in Black River estuary
- Monitored bays and estuaries for anoxic events
- Constructed rock dams and holding pools to prevent sedimentation and aid fish migrations
- ♦ Weekly Nitrate Testing
- Replaced alders with native trees and food shrubs
- Completed annual spring runoff and fall redd surveys
- Measured Stream flow rates in5 rivers
- Sea Lettuce harvesting with UPEI for research trials
- Co-Hosted Climate Change Forum with NSCC and PEI Gov

FCBB & NSCC Climate Change Forum

Friends of Covehead and Brackley Bays Watershed hosted this important meeting in partnership with the Rural Municipality of North Shore on June 21. This was an opportunity to learn from and question two members of the Government of Prince Edward Island's Department of Communities, Land and Environment:

Peter Nishimura, Senior Climate Change Adaptation Policy Advisor discussed climate change's local effects on land and water as well as plans by which we might deal with these changes.

Cindy Crane, Surface Water Biologist focused on how sediment and nutrients affect water quality and various options for sustainable improvements.

Harmful Effects of Beaver Colonies

Beavers when located in appropriate locations can provide benefits to watershed health, but when located in upper and middle sections of rivers they can block essential spawning habitat, they can also cause major damage to stream banks and can cause sever flooding to occur. If you have nuisance beaver colony please contact FCBB.
